Treasurer

Thank you to the 86 percent of residents who have paid their 2023 assessments. In order to maintain our assets and have reserves for future maintenance and replacement costs, it is necessary that all property owners pay their share. Please accept you share of responsibility for the community and pay your portion.

The Finance Committee and Legal Committee will pursue every avenue to collect the delinquent accounts. Anyone delinquent at this point is incurring late fees, and is not eligible to attend meetings, vote, receive marina cards or obtain approval from ARC for improvements or renovations to their property.

The Finance Committee has been hard at work since the beginning of the year, reviewing the 2021 Audit, recommending a reserve account for the office building, and maximizing interest income on our reserves. Additionally, they will meet again soon, to review the needs set forth by the committees on future reserves needed to maintain our infrastructure i.e., roads, community development, dredging and the spoil site, the marina, etc. We live in a beautiful community and we will continue to manage our reserves to meet the needs of Wedgefield Plantation.

As I write this message to you, the WPA is already deep into our fiscal calendar year with much already accomplished and much more yet to do.

The Board's major responsibility to you is our fiduciary management of the budget and yearly funds. This year we laddered our funds in CD's to gain more interest income from the Feds continuing interest rate increases. And we have set up a new Reserve account for the WPA building in anticipation of future repairs.

We also established two new committees, Community Development and Bid/Procurement. The Community Development Committee as you no doubt have heard, is looking into various development initiatives including a community pool, pickle ball courts and a playground for the children of Wedgefield. The Bid & Procurement Committee is a more professional management approach to our contracts that exceed \$10,000. In 2024 we will have significant expenditures for the canals that necessitate a critical analysis & management.

We are also looking to clean up the front entrance trim the trees, add significant more plantings and an illumination plan to increase the lightening at the front entrance for night.

We have a number of family planned fun events scheduled for this year, the first is our Easter Egg Hunt hope your family was able to attend and had fun (if it doesn't rain)

At the beginning of year the Board developed specific goals & objectives for each committee to accomplish this year. We are well into the process and you will begin to see the fruits of that effort as the year moves forward.

Water Amenities

We hope you all are enjoying watching all the fishing boats in our canals, both residents and visitors. Please feel free to fish from the HOA owned waterfront properties at the end of each canal and off the road and docks at the marina.

We are making good progress on obtaining the Army Corps of Engineers Permit to perform the needed canal depth maintenance program within our Plantation. Department of Health and Environmental Control will also require their Permit be obtained with the ACOE required Public Notification is performed. We have retained the A&E firm Earthworks of Murrells Inlet to interface with all 5 governmental agencies that claim an interest in our navigable canals but no financial responsibility. Even the ACOE suggests the use of Engineers with PE Licenses to interface with the Application. Weird stuff here.

We request that we all refrain from throwing anything into the canals, yes even yard refuse of any type. Please no trash or unneeded items. Landfill is on Highway 51 on the left past the Y.

We are striving to maintain the canals and marina for use by al owners in Wedgefield. Please let us know if anything is amiss.

It is important for HOA members to apply for a permit before building a new home. Also, it is important to apply for a permit when doing any changes to the exterior of existing homes. New paint? A new roof? Adding new exterior structures and improvements?

We make efforts to assist. We do not impose fines to raise money. Fines are only used to encourage compliance.

Application forms are available at the WPA Office. Our ARC Members can assist by phone or at office meetings and site meetings to help applicants.



Drainage

Ah, Spring showers. Drainage Committee prefers showers over storms and especially over hurricanes. We believe all under road pipes are open. We believe all HOA ditches are open. We know that the canals cannot carry off storm or hurricane waters fast enough to prevent some low lying areas flooding. Guess that is why FEMA requires flood insurance if you have a mortgage. Also why the canals need to be kept deep to help carry off more storm water. We have homes draining to the golf course and we have substantial golf course runoff draining to our canals and marshes. We are in this together.

What can we as individuals do to help: Keep our driveaway pipes clear. Keep our Swales (shallow ditches) clear down our boundary lines. Keep our front and rear ditches clear of clogs and debris. Our homesite drainage is our responsibility to maintain. ARC is striving to ensure all new construction has proper Drainage when turned over to Owners. Drainage assists ARC with this and serves on ARC Committee for this.

What about our roads: Good Questions- lawn sprinklers should not spray the road nor run so much as to call runoff onto the road. Front swale or ditch should be maintained or created to drain water away from the road.

We are taking action wherever a drainage problem is an HOA action item. If not an HOA action item, then we advise the Owner of that opinion. SCDHEC defines flooding as water that stands longer than forty-eight hours before it is considered a drainage problem.

We had a busy year full of brunches, lunches, holiday parties, and crafts. All while meeting new neighbors and friends.


