Presidents Report

As the calendar turns to July it is hard to believe we are now in the 7th month of the WPA HOA fiscal year already. When the Board reorganized after the November Director Elections and as your elected President, I asked each Committee Chair to establish specific goals & objectives they could complete through their committees for this year.

We then developed a spread sheet for the entire WPA HOA committee structure to meet timely action steps to complete by year end. That action is beginning to bear fruit.

The first accomplishment of this effort is from Meredith Marsh as the Chair of the Grounds Committee. The entrance way restoration project, which included clearing of vegetation, planting, trimming of trees, renovating the irrigation system and a new sign across from the Gate House and additional lighting of the entrance. We are not finished yet, as we will be doing more clearing and planting in July.

The next project is the work of the Capital Development Committee. The Committee was established last October but not organized until January, when I asked Stan Earnhart chair and to select committee members to set in motion specific objectives to include a pool, pickle ball & tennis courts, nature walkway and children's play area for the WPA HOA.

On the administrative side of the WPA HOA, we have laddered our Reserve Funds to increase our investment income and our Treasurer Valerie Cooper aided us in retaining a new CPA & accountant to handle our financial reporting and tax filing. In April, I established a committee with Bob McMahan as Chair to review the ARC Section III policy revisions. The Committee completed that task and reported to the Board at the June meeting and the recommendations have been forwarded to the ARC committee for their review.

At the June Board meeting we set up a subcommittee to review the WPA HOA Bylaws, Covenants and Policies with the objective of bringing all these documents into conformity with existing State law and common-sense enforcement protocols.

We continue to move forward on the major canal dredging work. Joe Myers as Water Amenities Chair is set to begin sometime in 2024. Ken Gaspaari as Roads Chair will be completing a new road study to examine how we spend our valuable resources for road improvements.

This year we started the Food truck Tuesdays as a way to seek broader social engagement in the community and from the turn out they have become very popular. Trina Davis, our Communications Chair has many more fun things in store for our neighborhood. We plan more events in the Fall which may include a Casino Night, Halloween Haunted Trail Ride and Christmas at the Manor House. Some of these activities are a partnership with Eagle Corp golf course and their Food & Beverage Manager, Justin.

So, as you can see, we have been a busy Board and in the last 6 months of our fiscal year we have more projects to complete.

Treasurers Report

Thank you to all who have paid their annual fees to the HOA. Over 90 percent of owners have paid and are current. In July, we will begin the process of attaching liens to those who are not current.

Our current CPA has been non responsive and has not done any work since January, even after multiple attempts to contact him. The Finance Committee met in June to review three proposals and with their recommendation, The Board approved Taylor and Gruber CPA to produce our monthly Financial statements, and Joan Hodges to conduct the audit of the 2022 year end statement and file our tax return.

A new five year Reserve Study is underway to provide the Board a solid road map for future funding needs to maintain our current assets such as our roads, marina and landscape needs.

Lastly, the Finance Committee in conjunction with the Board of Directors will be looking at options to fund some capital improvements projects such as the pool, pickle ball and tennis courts and nature trail.

Drainage

This is the Low Country of South Carolina with parts at or below sea level. SC DHEC holds that any standing water that is gone within 48 hours is not a problem. Longer if a named storm, like a hurricane.

Another government Agency is Federal Emergency Management Admin (FEMA) which decides what is flood-able land. Most of WEdgefield is now according to FEMA in a flood plain. If a mortgage is FHA hen Flood insurance is required now for that home. If no mortgage, then up to the owner. FEMA ran into some whopper of claims from Mississippi River floods so decided to expand flood insurance requirements so here we are. No, Wedgefield is not sinking just redefined by the feds.

This committee is not aware of any drainage problems which are within the HOA's responsibilities to the community. We are rushing the storm waters to the canals and other conduits to the Black River.

A Hydrologist studies our Drainage Map and opined that at least 20% of the Golf Course excess/storm water ultimately drains into our Canal system then the Black River. Some of our properties drain onto the Golf Course which itself drains into canals and marsh. Quite a complex drainage system.

Marina: Should we spend Capital Improvement monies to expand the parking lot for boats/trailers? Crowded at times.

Yes, boating has gashed thru the plastic look good material on a couple of float blocks but foam flotation still buoyant. Repair estimates are running \$4,000-\$5,000.

Canals: Depth Maintenance Project is in full execution with Earthworks Engineering Firm providing the Professional engineering and analysis of the needed steps to obtain all 6 government agencies' permits and approvals to maintain a safe canal water depth in the canal system for resident and visitor Boating.Can swim at own risk in canals but not at the marina landing, in case you were wondering. Sunbathing is optional. We hope to have the project successfully completed by March 31, 2025- started summer of 2022. 3 year project.

Our 13 member committee is trying to keep communications open so ask if you have a pertinent question. Oh, yes trying to maintain at least t6 feet depth in the middle 30 feet in all the canal system. Thanks for that question. Actually the main 3 canals nearest the river, their depth will be 8 feet. (another question there). Yes, because any owner can us the marina landing and anyone can boat in the canals, we will accept monetary funds from everyone willing to help with the funding of the project. Thanks in advance if you do help this great Humanitarian Cause. These canals carry off more than 20% of the Golf Course storm water.
