Vice Presidents Report

Toward the end of May, Keith Johnson, a board member and chairman of the Architectural Review Committee, submitted his resignation effective May 25th. The board feels it was fortunate to have two well qualified candidates step up and submit resumes for the vacant position. The Board selected Bob McMahon to fill the open seat effective immediately. We welcome Bob to the Board and look forward to his participation and input in all matters that come before the Board. If you get an opportunity, please extend your best wishes and welcome him as well.

There will be an election in November with three board seats available. Anyone wishing to run for election and serve on the Board needs to contact the office and ask the office to forward their name to Tom Macedo, who has graciously agreed to serve as nominating committee chairperson. We also need volunteers to serve on both the nominating and election committees and request all interested residents willing to serve on either committee to contact the office and submit your name for inclusion.

Secretary's Report

Preparations are underway for the annual meeting and election in November. The packets will be mailed to all property owners by early October., listing the candidates and the 2019 budget. Residents and property owners may vote by proxy by filling out the enclosed form and mail it to the office in the addressed envelope. Any proxies not received 10 days prior to the election will require that their votes must be cast in person at the annual meeting. As a reminder, you must be in good standing at least 10 days prior to the annual meeting to be eligible to vote or attend. It will be held at the Georgetown Presbyterian Church on Black River Road on November 17th, 2018.

An election committee is being formalized, consisting of 10 members and several alternates. Many of these have served in the past, so it is hoped the election will move smoothly and quickly without_delay or controversy. HOPE TO SEE YOU THERE!

Complaints must be presented to the office either by letter or e-mail. No verbal issues will be considered. Confidentiality will always be maintained. The Community Liaison Chairperson will either address the complaint or forward it to the fellow Board Member for input before any action or response is given.

Treasurers Report

Any property owners that have not paid their 2018 assessments will be responsible for any and all legal fees incurred by the WPA for the collection purposes. Attorney involvement can cost \$400 or more.

We presently have \$614,160 in Reserve Accounts for future expenditures necessary to maintain the Plantation. We have received an updated Reserve Study used to determine anticipated future capital expenditures. The majority of our Reserves are allocated to Roads. The Finance Committee will be meeting in August to prepare a proposed budget for 2019. Input from Board Members will be requested.

Canal Dredging Committee

We have been hard at work collecting donations from the canal lot owners. As of this writing we have collected over \$180,000 of our \$200,000 goal. The spoil site work has begun and should be completed in early August. The dredging will begin in December. All canal lot owners are encouraged to participate if you have not already done so. There will be an open community meeting on August 7th to give residents an update on the dredging. We really appreciate the support we have received from everyone. It has been our goal to do this project as fairly and equitably as possible and without all of the controversies of the past.

Legal Report

As a result of foreclosure proceeding due to non-payment of annual WPA assessments, the WPA now owns two properties designated as building lots here in Wedgefield. All liens and encumbrances have been removed from these properties and the WPA is making arrangements to offer them for sale.

The two parcels that will be offered for sale are Lot 485 Address: 1131 Francis Parker Rd. and Lot 446 Address: 1226 Francis Parker Rd. It is anticipated that these parcels will be placed with a realtor of the Board's choosing and available for purchase in the very near future. If you have an interest in purchasing these properties, call the office and more information will be provided to you as it becomes available.

As a cautionary note, to those of you who have still not paid 2018 or previous years assessments, understand that the WPA can and will execute foreclosures on properties with delinquent assessments. You are encouraged to make payment arrangements and avoid the eventual loss of your property.

Golf Course Update


