### **Treasurer's Report**

Happy New Year, Wedgefield Neighbors! And thank you in advance for sending in your dues! Below is a brief recap of activities from 2023:

- Researched and recommended a new firm to produce our monthly financial statements. Kelly Moore was selected. He will begin working on the statements for 2023 and catch up for 2024.
- Researched and recommended a new firm to conduct the audit of our 2022 financials: Joan Hodges. The audit is complete, and the Board and finance committee attended a presentation of the audit on January 11, 2024.
- Committee developed a 2024 Proposed Budget and they unanimously agreed not to not raise the dues for 2024. The Board agreed with the proposal and passed the 2024 Budget in August.
- Reserve Study updated, and it was agreed to hire the same company that completed the Reserve Study in 2018. This is complete and has been reviewed and revised by the Finance Committee.
- In looking at the Reserve requirements moving forward, it was agreed that the association dues will need to be raised in 2025. The updated Reserve Study along with the Pavement Condition Survey, will help guide us as to the amount.

Reserve amounts were moved to various CD's to take advantage of favorable rates:

5/15/24 - \$50,000 (5.40%) CD Citizen Bank

2/01/24 \$50,000 (5.30%) CD Wells Fargo

1/24/24 \$223,760.85 (5.12%) CD TD Bank

<sup>\*</sup>2/23/24 \$50,000 (5.25%) CD Bank of America

\* This CD is set aside for operating funds per the August Board meeting vote.

In addition to the CDs, the HOA has 3 money market accounts: Edward Jones \$290.888.81 (4.74%), South Atlantic \$6,625.43 (0.07%) and TD Bank \$4,017.09 (0.10%), in addition to its operating account, South State \$154,925.00, Debit Card account \$2,104.00, and ARC \$8,001.33. (Balances as of 12/31/23)

In 2024, the Finance Committee will hear from the Board on their priorities for the upcoming year and beyond. The committee will make recommendations to meet those goals for both spending and raising dues, using the Reserve Study as its guide. This may require a multi-year approach and changing the percentage of reserve contributions.

In addition, we will work hard to ensure that the financials are caught up to the current year and share the monthly reports at the Board meetings for all to stay informed.
