ARC Report

Please make sure you fill out a permit and have it approved before any exterior work is done on your property. This includes things like painting, sheds, fences, concrete work, docks, and recreational equipment. We promise to make this process as easy as possible to improve your property and the Plantation in general plus it would save you money that might be charged for lack or WPA approval. Call the WPA office if you have any questions involving the permit process.

PLEASE BE AWARE THAT THE ISSUANCE OF A PERMIT FROM THE WEDGEFIELD PLANTATION ASSOCIATION DOES NOT RELIEVE THE OWNER OF THE PROPERTY, THE RESPONSIBILITY OF OBTAINING ANY APPLICABLE FEDERAL, STATE AND/OR COUNTY BUILDING PERMITS.

The ARC has received several questions concerning the location of trash cans. Trash cans should be screened from view per paragraph 4.02.17, section III of the Wedgefield Plantation Association Policy Manual. This paragraph also includes HVAC units and propane fuel tanks. These "service, utility, and storage areas" should be screened from view(from the front of the house) Please make note of this and share with your neighbors as we all want this to be a nice neighborhood.

The following permits have been recently approved by the ARC: Tree removal on William Screven & Wedgefield Rd., Lot clearing on Jericho Court and Francis Parker, and a re-roofing on King George and John Waites.

Drainage

The first part of this report is to update everyone on the status of the work that was supposed to start at near the intersection of Wedgefield road and Governor Johnson. The work was delayed due to a change in scope of the project that required new quotes for the work that needs to be done. It is expected that the work will begin soon, and we will update everyone before the project starts. The good news is that the proposed work will not require any disruption of the road and we will instead be done across HOA property at the side of the road at the side of the road.

The second part of the report is to review the responsibilities of the HOA drainage committee and what HOA members can do to ensure that any waters, whether from rain or tidal flooding, can move effectively through the ditches and pipes that channel it to areas where it does not negatively affect any homeowners. A review of our drainage system during recent heavy rainstorms has shown that it is effective at moving rainwater to drains and the retention ponds, with some small areas of standing water and impeded flow. Some homeowners have advised us of areas of concern, and we will address those as needed. One thing we can all do to help alleviate flooding is to keep the ditches and swales in front of your homes clear of debris such as pine needles and leaves. This not only ensures that your property will not flood but also your neighbor's properties downstream will not flood as well. Where needed the HOA will contract for removal of debris from undeveloped lots and HOA common properties but will not do so on developed properties for obvious reasons. Reducing the amount of debris that flows downstream in the drains and swales will help keep our drainage and dredging costs down and ultimately help to keep your assessment cost from increasing.
