TREASURER'S REPORT

The South State Operating Account as of June, 2017 was \$156,715.47. This account is used for regular operating expenses such as electrical bills, grounds maintenance, wages, etc.

The Reserve Accounts had a balance of \$447,981.24 as of June, 2017. These accounts are used for future maintenance, repairs or replacements of the existing assets of the association. The amounts held in each account were established by Reserve Data Analysis, Carolinas on June 11, 2013. This was an in-depth study of the future needs of the Plantation by comparing national standards. The balances held in these accounts are established by a percentage formula recommended by the reserve study. These reserve fund are the portion of the annual assessments that are not used for normal operation.

Wedgefield Resident forms a new <u>non-profit</u>

A new non-profit organization will launch its programs in August. Tidelands Respite Care is a non-denominational non-profit organization 501(c)(3), providing social day programs, support groups and community resource information to individuals, families and caregivers affected by Alzheimer's disease and other forms of memory loss.

Wedgefield resident Pam Gilligan is the cofounder and executive director of Tidelands Respite care. They will provide safe and secure day programs staffed by experienced staff and well trained and caring volunteers, in a wellmanaged social group setting in which participants can socialize, contribute to, and benefit from therapeutic, light exercise and motivational activities. # **Grounds Report**

I have chosen my article space to explain an ongoing effort to benefit our community. Since the golf course had been closed for nearly a year, it's appearance had deteriorated rapidly. A lot of talking and complaining about its' condition occurred, but nothing was being done. An ad-hoc committee was formed this past May by several residents seeking permission and donations to hire someone to mow the course periodically. This became a popular approach and has continued to date. A terrific contractor was hired, whose fairness and work ethic have been a blessing. Donations were soon being received at a rapid pace and work was begun. However, those funds are being depleted and the movement needs our help to continue. At present, the entire mowing of the golf course needs to be done every three weeks, at a cost of approximately \$2,200 per mowing. Believe me, this is a very reasonable amount for the scope of work being performed. Many of those that had contributed have failed to continue to do so and many more either have not or are unaware of the committee's efforts. The fund currently only has approximately 1/3<sup>rd</sup> of what is needed for July, and the mowing will likely be needed to continue through September. A small contribution of \$20 per month per household is all that is being asked. This is a small price to pay to avoid the horrible appearance that would soon develop. As promised, detailed records are kept of the contributors and amounts donated. Should the golf course become self-sustained, any remaining monies will be returned to those who donated.

There are several ways to contribute. Checks and cash in an envelope should be addressed to the Wedgefield Mowing Group, the put in the drop box at the WPA office or at the Georgetown Kraft Credit Union. You can also contact any of the ad-hoc committee members who will forward the funds to the account. These members are: Butch Williams, Bob Buice, Hinson Floyd and Wyndell Peacock. These people are very dedicated to this cause and we all owe them much gratitude.

A meeting to discuss the activity and funds of the mowing group is held in the WPA office at 6 pm on the third Thursday of each month, and everyone is welcome and urged to attend. Your input will be greatly appreciated and please help us to continue this great effort.
