Women of Wedgefield (W0W)



Drainage Report

Working with Water: Rain Barrels and Rain Gardens

For coastal SC, the waterways and tropical climate are a huge draw and sometimes, a big challenge. Heavy downpours and high tides often lead to flooding and polluted runoff. But as a community, we can make a difference.

Two simple practices, rainwater harvesting and rain gardens, help us turn stormwater from a problem into a resource. A rain barrel collects water from your roof to reuse in the yard, cutting down on both flooding and water bills. A rain garden, planted with native flowers and grasses, slows and filters runoff while adding beauty and habitat for pollinators.

When many households adopt these small steps, the impact on the overall drainage system can be significant.

For a 1000 square foot roof with 4 gutters or corners where rainwater is collected equally, a 0.4" storm will fill a 60-gallon barrel. A 1" storm falling on this same rooftop will generate a total of 623 gallons of runoff. Every improved lot in Wedgefield generates nearly twice that amount! Both of these methods provide an effective way to deal with watershed issues. Use the link below to learn more.

Water Amenities Report

The bulkhead work is finished at the boat landing. We are working with a contractor to get started cleaning up the area and get some grass growing on the repair area

The docks in the landing are in rough shape. We propose to the board replacing the docks at the landing: the north dock this winter and the south dock next winter.

On August 12th, the board voted to contract with Brunswick Dredging to dredge the canals. This work will begin in early September after Labor Day. We will keep the community updated on any potential issues with using the canals. It's our understanding that the boat landing will remain open during the project.







Secretary's Report

The WPA office is hard at work preparing for the Annual Meeting. There are 11 members running for three open Board positions. Voting for the new Board of Directors will take place at the WPA Annual Meeting on Saturday November 15. Please remember the doors close promptly at 10:00 AM at Winyah Auditorium. Late arrivals will not be permitted to enter. You may vote in person or by Proxy. You will receive a proxy ballot in the Annual Meeting Packet, which will be mailed the first week of October.

Our Annual Meeting preparations started last month as August 1 was the deadline for all By Law change proposals. The changes submitted were presented to the Legal Committee for review in consultation with the Board Attorney. The Document Review Committee has submitted a substantial number of proposals including one for Covenant #26. This is the first time the WPA will be voting on a Covenant change. There are several proposals that will have a major impact on the future of the Association, so please, carefully review the information and ballots you receive in the Annual Packet. All documents for the Annual Meeting must be submitted in their final form by Wednesday September 24 to the Election Committee, so they may be printed and prepared for mailing in accordance with policy obligations.

The 2025 Election Calendar:

- Wednesday Sept 24, All documents for the Annual Meeting Packet are due.
- Tuesday, September 30, Election Committee meeting for Packet assembly.
- Wednesday, October 1, Mail Annual Meeting Packets.
- Tuesday, October 7 at 7:00 PM Meet the Candidates Night.
- Wednesday November 5, Proxy votes are due by 3:00 pm.
- Tuesday, November 11, Election Committee meeting for Proxy processing.
- Saturday, November 15, Annual Meeting at 10 AM.

Due to the large number of candidates and By Law proposals, we are recruiting a large Election Committee that will include at least 15 counters for 5 three-member counting teams. If you have interest in participating in the Election Committee, or if you have any questions regarding the Annual Meeting, please contact the Election Committee Chair, Stan Earnhart through the WPA Office.

Document Review Report

The Annual Members Meeting in November, 2025 will permit the membership to vote on several issues regarding By-law corrections, amendments and additions, along with a major covenant change. The proposed changes have been reviewed by the Legal Committee and the Board Attorney for inclusion in the Annual Members Meeting.

There are sixty-one (61) By-laws changes involving corrections to existing By-laws. The 61 changes do not affect the intent or function of the By-law.

There are two (2) minor changes clarifying expenditures and tabulating how a "Special meeting" may be called. There are five (5) significant changes. These amended and/or new By-laws should be carefully reviewed and voted upon by the membership.

The most significant change involves Covenant 26, which currently requires 100% of the membership to agree to Covenant changes in order for the Covenant to be changed.

Read and consider the covenant carefully as it can affect the future of Wedgefield Plantation Association.
